8. College/ Institute is requested to submit the residential address proof, Aadhar card along with mobile number of all teaching & non-teaching employee in case of any changes.
9. The College / Institute must to submit an affidavit that the land/ buildings for the courses have been demarcated exclusively for the purpose of course (name & intake) under Aryabhatta Knowledge University, Patna within **thirty (30) days** from the date of issue of this letter.
10. This extension of provisional affiliation will be subject to approval given by the State Government.
11. In the light of University notification vide letter no. 004/FIN/038/AKU/2014- 1323, dated 18/05/2020, the College/ Institute is directed to deposit the amount of Endowment fund in any nationalised / scheduled bank branch as Fixed Deposit (FD) in the name of college and thereafter the said FD will be pledge in favour of the Registrar, Aryabhatta Knowledge University.
12. If, Endowment Fee has not submitted within three months from the date of issue of this letter, no student shall be considered for registration and examination.



The Inspection team Ref No-006/Affili/771/AKU/2024(VOL-II)-3554 visited to Nexus College of Management and Higher Studies, Katakari PO+PS- Sathi, West Champaran- 845449 visited on 23.07.2025 an inspected the infrastructural and intutional faciality available in the college per course BCA– 120 seats & BBA– 120 seats for academic session 2025-26. The inspection team is pleased to report the following observations.

Suggestion:-

1. Building for the courses to be affiliated with Aryabhatta Knowledge University, Patna should be demarcated with proper sign boards.
2. The Institute should be asked to submit an affidavit declaring that the demarcated building is not being used for any other purpose.
3. Dedicated Lab for the courses with required number of computers with updated software should be installed and made functional.
4. Khasra plan/Nazari Naksha should be submitted.
5. For First year 4 class rooms are required. The College should be asked to ensure availability of Sufficient classroom accordingly.
6. Smart classes and digital board are required
7. Benches and desk are required.
8. Separate washroom for male and female are required in all floor.
9. Faculty should be appointed under the University representative and subject expert.
10. Library should be established under the AICTE norms.
11. Computer lab should be established according to AICTE norms.
12. Computer hardware and software should be established according to AICTE norms
